

The committee thanks all office bearers and other club members for their efforts throughout the year.

Overview

- The key register has been maintained as required.
- The clubhouse lease agreement with Brisbane City Council is due for renewal in April 2020.
- The only regular sub-lets of the clubhouse are to the Sprite Car Club (monthly) and the XR Falcon Club (once annually). A local choir and associated amateur theatre company uses the building irregularly as a rehearsal space.
- Club operations have continued with no major changes from the previous year.
- The Club's financial returns have been prepared and/or checked by David Star (Tax Agent) and John Dixon (Accountant/Auditor) as for previous years. The Club's financial position remains strong and there were no matters brought to the committee's attention by the auditor.

Financials

Total asset value at 30 June 2019 was \$111,502 compared to \$119,559 at 30 June 2018. The club reported a loss for taxation purposes and is now carrying a loss of \$4,994 into future income years. The \$1,520 tax prepayment for 2018-19 will be full refunded by the ATO. The fully audited financial report is available for perusal and a summary will be published with this report in the October 2019 Club Magazine.

Expenditure

The committee ensured all required expenses were paid and the club got the best possible value for money. We did a lot of work to the clubhouse this year, much of this related to termite damage and the eradication of said pests. The Sani-Flo macerator/pump in the Gents toilet was replaced and there are further minor works to be completed along with some approaching major items. Printing and mailing of the magazine is well under control but it still remains as the club's largest recurring expense.

Membership

Membership on 30th June 2019 stood at 342, twenty-four (24) fewer than the same time last year.

Major Events

The Hot Wheels and Cool Classics Car Show incorporating the MOCA QLD INC State Concours to be held on 8th September 2019 was deep into the planning stage as of 30th June. Members have voted to hold this event every second year, so this boost to club finances did not happen in the 2018-19 financial year. Planning is already under way for the 2021 MOCA Nationals to be held on the Gold Coast.

Charitable Donations

The club donated \$5,000 to Drought Angels in August 2018.

Club Runs

Neil De San Miguel (Run and Events Co-Ordinator) has continued the good work to get us out to interesting places as a car-obsessed group. This is more than core business for the club, it's our whole reason for being, so it's particularly nice when we get a big turn-out of members for any of the club runs. Les Nye and a core group of members have continued to organise mid-month mid-week runs, which are proving to be quite popular with those who are available during normal working hours on Wednesdays.

Club Meetings

Most general meetings are attended by 30+ members. These regular attendees are the operational core of the club, filling the elected positions to keep the club operational and viable.

Merchandising

Yo Holst continued in this role, making a few changes to the products offered due to opportunity and necessity.

Magazine / Website

Robyn Messenger continues to do a great job running these public faces of the club along with her other duties.

<u>Club Person of the Year – 2018</u>

Neil De San Miguel earned the "Clubbie" award after going very close in 2018. This award is points-based with points awarded for participation in club activities. Neil was just ahead of a strong field. The 2019 Club Person of the Year will be announced at the January 2019 general meeting.



Independent Audit Report

We have audited the accompanying financial report, being a special purpose financial report, *Mustang Owners Club of Australia (Qld) Inc.* which comprises the statement of financial position as at 30 June 2019, the statement of comprehensive income for the year then ended, notes comprising a summary of significant accounting policies and other explanatory information.

Committee responsibility for the financial report

The Committee is responsible for the preparation and fair presentation of the financial report and have determined that the basis of preparation described in Note 1 is appropriate to meet the requirements of the Associations Incorporation Act 1981 and the needs of the members. The Committee's responsibility also includes such internal control as Committee determine is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.

Auditor's responsibility

Our responsibility is to express an opinion on the financial report based on our audit. We have conducted our audit in accordance with Australian Auditing Standards. Those standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance whether the financial report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial report. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the Association's preparation of the financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Committee, as well as evaluating the overall presentation of the financial report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Independence

In conducting our audit, we have complied with the independence requirements of the Australian professional accounting bodies.

Electronic publication of the audited financial report

If the *Mustang Owners Club of Australia (Qld) Inc.* intends to electronically present the audited financial report and auditor's report on its internet website, responsibility for the electronic presentation of the financial report on the internet is that of those charged with governance of the *Mustang Owners Club of Australia (Qld) Inc.* The security and controls over information on the website should be addressed by the *Mustang Owners Club of Australia (Qld) Inc.* to maintain the integrity of the data presented. The examination of the controls over the electronic presentation of audited financial report on the internet is beyond the scope of the audit of the financial report.

Audit report qualification - Basis for qualified opinion

Receipts from cash donations and other cash fundraising activities are a significant source of revenue for **Mustang Owners Club of Australia (Qld) Inc.** The **Mustang Owners Club of Australia (Qld) Inc.** has determined that it is impracticable to establish control over the collection of donations and other fundraising activity revenue prior to entry in its financial records. Accordingly, as the evidence available to us about revenue from these sources was limited, our audit procedures for donations and other fundraising activity revenue had to be restricted to the amounts recorded in the financial records. We therefore are unable to express an opinion on whether cash donations and other cash fundraising activity revenue obtained by the **Mustang Owners Club of Australia (Qld) Inc.** are complete.

Qualified opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the financial report *Mustang Owners Club of Australia (Qid) inc.* presents fairly in all material respects in accordance with the accounting policies described in Note 1 to the financial statements, the financial position of the *Mustang Owners Club of Australia (Qld) Inc.* at 30 June 2019 and its financial performance and its cash flows for the year then ended.

Basis of accounting

Without modifying our opinion, we draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling Committee reporting responsibilities. As a result, the financial report may not be suitable for another purpose.


